



## DOG DAY CARE FEES AND SERVICE AGREEMENT

**ALL FEES AND CHARGES DUE UPON PICK UP.**

\*\*We are not equipped to keep dogs overnight. A late fee of \$15 per half hour will be charged for late pickups. If you are unable to make it here by closing time, an employee will be required to take the animal to his/her home for care. You must pick up your dog the following day during drop off/pick up hours. A \$100.00 fee per dog will be added to your bill (in addition to regular day care fees and late fees) for this service.

\*\*If your dog(s) arrives on the property with **fleas or ticks**, they will be bathed and an additional charge will be added to your bill. If your dog(s) has fleas or ticks and requires quarantine or a vet visit, you agree to pay for all charges involved.

**\*\*WE DO NOT TAKE HUMAN AGGRESSIVE DOGS! A \$40.00 A DAY FEE WILL BE ADDED FOR DOGS THAT DISPLAY HUMAN AGGRESSION!**

**I certify that I am the actual owner or duly authorized agent of the actual owner of the animal described above. I personally assume total responsibility for this dog(s) and agree to indemnify and hold harmless Companion Dog Services LLC (DBA Austin Canine Central and DBA Joyce Morgan Dog Training Center) and its business owners, instructors, employees, independent contractors, participants, property owners, and insurers of all these parties (the "Parties") from and against any and all expenses, losses, claims, liabilities of any nature that arise from or are incident to the use of the facilities and equipment for dog day care, belonging to or used by the Parties, not caused by the gross negligence of the Parties.**

I authorize Austin Canine Central to do whatever they deem necessary for the health and well being for my dog(s) and agree to pay for all expenses relating to the same. By signing this contract I am giving my consent for Austin Canine Central and its employees, independent contractors, and/or owners(s) to take my dog to the vet if deemed necessary by any of the aforementioned parties and that I, the owner of the pet(s), agree to pay for any and all such bills, and should my dog bite or cause injury to another dog or person I agree to pay for any and all medical or veterinary expenses. I agree to pay for auxiliary services or products requested by me, such as, but not limited to, training, transportation, bathing, etc. I agree that I am solely responsible for any damages that the above mentioned pet may cause through malicious or improper conduct to property, persons, or animals.

I understand that my dog(s) will be allowed to play with other dogs while staying at Austin Canine Central. I understand that dogs are not wholly predictable and I will not hold the Parties responsible for any and all loss, damage, and/or injury to my pet(s) or myself resulting from the behaviors displayed by any of the dogs on the premises of Austin Canine Central property, not caused by the gross negligence of the Parties.
